<p>Die gemiddelde bruto gearpste tonnemaat (fisies oor die skaal, vir die jongste drie opeenvolgende oesjare, bv 2011, 2012 en 2013) sal as basis vir enige/alle berekeninge aangewend word.</p> <p>'n Glyskaal, gekoppel aan sekere bande (tonnemaat-intervalle), is ontwerp en word in die tabel op die volgende bladsy getoon.</p> <p>Die ledegeld is betaalbaar in twee gelyke paaiemente – onderskeidelik jaarliks in Oktober en November – en sluit BTW uit.</p> <p>Vir onafhanklikheid en handhawing van vertroulikheid is SAWIS getaak om die gemiddelde bruto tonnemaat per kelder te bepaal, die onderskeie waardes toe te voer, asook die berekeninge vir elk van die spesifieke bande te kontroleer.</p> <p>Slegs die eindresultaat word aan VinPro bekendgemaak, ten einde die fakturering en administratiewe proses te volvoer.</p> <p>Die jaarlikse fooi-hersiening sal gebaseer word op die heersende VPIX en finale goedkeuring geskied by die VinPro-direksie.</p>	<p>The average gross harvested tonnage (actual on the scale, for the past three consecutive seasons, e.g. 2011, 2012 and 2013) will serve as a basis for any/all calculations.</p> <p>A sliding scale, linked to specific ranges (tonnage intervals) has been developed – see the table on the next page.</p> <p>The membership fees are payable in two equal instalments – respectively annually in October and November – and exclude VAT.</p> <p>In order to remain independent and ensure confidentiality, SAWIS has been tasked to determine the average gross tonnage per cellar, apply the respective values and verify the calculations of the specific ranges.</p> <p>Only the end result will be shared with VinPro, in order to finalise the invoicing and administrative process.</p> <p>The annual fee revision will be based on the VPIX at the time, and subject to final approval by the VinPro board.</p>
